	VN asked RS and SM to provide an update on how things were at the present time SHINS

	SM said it was very difficult to sum up the last few months as so much has changed. She said it was good to receive the DfE guidance for September but there was still a lot of work to be done in order to have the school operating for all children in a safe way in September. She said work was ongoing on this but at the same time staff were still having to carry out the normal end of year activities. She said staff were focussed on trying to provide the best for the children who have experience a lot of disruption over the last few months  Work is ongoing to try and restore the classrooms to accommodate gropes of 30 children. She said that a number of classrooms had been used to store furniture that had been	
	removed from other rooms to accommodate smaller groups of children who had to be given more room.  SHJS	
	RS said it was a similar picture at the Junior School. Events were taking place for Year 6 children to help them celebrate their time t Stoke Hill.	
	Planning was taking place for September. RS said that Jamie Sullivan had looked at the online learning activities to ascertain the level of engagement. He said that there some children who had done very little online learning and teachers would need to be mindful of this when they were planning work for September and provide extra help and support for these children.	
	AB asked if children would be asked to share what they had done during the lockdown. She asked how to make those children who had not done the online learning feel that activities they might have done were equally valuable. RS said that each class would be asked to make a "Hope and Dreams " book in which every child would be asked to make a contribution. AB said that she felt it was important to celebrate all the things the children had done.	
	VN asked about Transition for year 2 children. SM said that both schools had been working on this. Year 2 children had been given an opportunity to meet their new teacher via Zoom. Also, the current Year 3 children had made videos for Year 2 children to share their experiences in Year 3. She said that the SENCO had made calls to vulnerable children in Year 2 to provide extra support. Some of these had been in school during lockdown and had been able to go to SHJS to see what it was like.	
	VN asked if there had been any reactions from parents. RS said that the only queries were related to start times and procedures for September	
	AB said she had received lots of positive comments from parents. She said that some had queried why children from SHJS had been allowed to go into school and say goodbye to teachers, but Year 2 children had not. RS said that children had only been allowed into collect belongings. AB asked if Year 2 children would be given an opportunity to say goodbye to SHINS. RS said it would be difficult at present as mass gatherings were not allowed.	
	AP asked if there would be any guidance issued for children attending Breakfast and After School clubs. RS said that Lisa Sinclair was currently working on this. It was planned to keep different year groups apart. Records would have to be kept of where children had been.	
	AP asked if a local lockdown was to be put in place in future would there be provision for online learning.	
	RS said this was being worked on. SM said that both schools were much better prepared to cope with this now than they had been back in March.	
	CE queried the requirement for children to arrive by foot from September. She asked if tis excluded those children who needed to use wheelchairs. RS said this was not the case. He said that cycles and scooters had been excluded to try and prevent the children congregating in groups.

	CD asked about assessments for next year. She asked what the expectations would be. RS said that the only guidance they had received stated that the assessments would be carried out as normal. CD asked how all the work on interventions that had taken place this year, prior to lockdown, would be recognised. SM said that the School Improvement Plan would address these issues. She said that the aim was to be in the same place this time next year as would have been expected if lockdown had not taken place.		
	TU asked if there would be any reduction in the curriculum to concentrate on basics. RS said that there would be some extra work on the basics, but this would be done by extra emphasis in other areas such as History. He said that some work had been carried out by the University of Sussex which had suggested that reading good quality novels to the children helped to improve their reading and writing.

	LH asked about PPE. She said that this was confusing and asked for clarity. RS said that they were following the DfE guidance which stated that the children should not wear masks. LH said that the wording should be the same for both schools. AB said that there might be some children who wanted to wear masks. RS said that they were following the DfE guidance. He added that he would not be happy teaching children who were wearing masks. SM said that it was important to concentrate on other measures such as regular hand washing and distancing. DM said that if some children were wearing masks then this could be unsettling for other children and make them anxious.
